**TERMS and CONDITIONS:**

- Valid for tickets issued January 1, 2023 through December 31, 2024
- Valid for travel between January 1, 2023 through December 31, 2025, based on outbound transpacific flight date
- Valid for tickets issued in the USA and Canada. Travel must originate in the USA and Canada, no SOTO allowed
- Approval Code: **FNA-092** (MUST be shown in “Tour Code Box”)

5. Endorsement Box: "Non End/RRT"; and must include "PE TRNSPAC" (for Premium Economy Class ticket only)
6. One-Way Fare: Commission applicable to C/J/D/K/L/P/Y/M/S booking classes
7. Child Fare: Applicable for commission (75% of adult fare)
8. Infant Fare: Applicable for commission (10% of adult fare)
9. Refund/Reissue Charge: Normal rules apply; refer to your GDS
10. Other rules:
  - a. This USA/CA – TPE/S.E. Asia/N.E. Asia/China/BNE commission applies to the applicable published fares listed above
  - b. All flights (except U.S./CA domestic portion) are valid on EVA on-line (operating) services only. U.S./CA domestic portion applies for through fare tickets only
  - c. U.S./CA domestic interline booking: refer to GDS for detail booking class code & routing. Review examples below to determine if Domestic interline flights are commissionable
  - d. This commission is exclusively for CCRA Air participating agencies. **These commissions can not be distributed via the internet or shared with anyone outside of your agency**
  - e. These commissions can not be combined with any other EVA promotions
  - f. No SOTO; all travel must originate in U.S./CA only
  - g. Cross cabin sell and combine fare allowed; please refer to GDS
  - h. Agency may NOT claim additional commission
  - i. Other restrictions apply; please refer to GDS for detailed fare rules
11. If mixing fare basis types – for example, C outbound with K return, calculate 20% outbound and 15% on return and claim the dollar amount of commission
12. EVA reserves the right to forward unreported ticket(s) to ARC/BSP for collection at Published Normal C/K/Y Fare minus normal commission. Special commission or Incentive commission may not be claimed on any unreported ticket.

## **New Fare Rule - Penalties**

### **No Show:**

- Most restrictive rule apply
- No-show fee is charged per ticket, regardless no-show on any segment, charge the highest no-show fee of the outbound and inbound fare basis

### **Refund:**

- Most restrictive rule apply
- Cancellation fee is charged per ticket, regardless the refund is at inbound or outbound, charge the highest cancellation fee of the outbound and inbound fare basis

### **Changes:**

#### **6- CHARGE THE HIGHEST CHANGE FEE OF ALL CHANGED FARE COMPONENT PER TICKET**

- If outbound changed, inbound remains → charge the change fee of outbound fare
- If inbound changed, outbound remains → charge the change fee of inbound fare
- If both outbound and inbound changed → charge the highest change fee between outbound/inbound fare

## NON-Through Fare Commission samples, Effective May 1, 2019

### Example 1:

The commission for below itinerary with sector fares:

3% for sector fare DFW-LAX-DFW with AS (LH70XVMN/LH4OAVMN):  $(\$228.84 + \$228.84) \times 3\%$

8% for BR through fare (BLXU):  $(\$485 + \$485) \times 8\%$

Commission applies to AS segments as long as the entire ticket is issued as one and validated on BR
